Fundamentals of Equipment Finance For The Pricing Professional

Geared toward new SuperTRUMP users needing the finance background to learn SuperTRUMP. For certification, students must demonstrate an understanding of basic lease terms including yields, risks, residual and related concepts, as well as cash, tax and accounting considerations.

SuperTRUMP Fundamentals

For those both new and currently using SuperTRUMP to price basic leases and loans and print out and interpret various reports. Students will gain a broad, working knowledge of the program and its uses. Prerequisite: basic knowledge of finance or completion of Fundamentals of Equipment Finance for the Pricing Professional.

Advanced SuperTRUMP

Students choose three classes from a variety of topics. Certification is given upon completion of each class. Prerequisite: extensive experience with SuperTRUMP or completion of SuperTRUMP Fundamentals. If there are enough students with an area of interest not already covered by any of the current topics, Ivory will create a new Advanced Course. Please check Other: on the Registration Form in the box for Advanced Courses, and describe your idea for a new topic. The following is a list of the current class offerings:

Advanced Cash Flow Screen

Learn advanced uses of the Rent, Loan and Periodic Expense and Income screens, complex step-up structures, locking and targeting for one-off structures, "Inflation Factors,"

variable interest rates, mid-period rate changes, etc.

Asset Breakout

Learn how to use one of SuperTRUMP's latest additions, the ability to breakout assets and associate them with each of the other parameters, such as rents, fees, etc. This allows for asset level accounting and for simplified analysis of terminations in a multi-asset transaction.

Custom Reports

Learn how to customize reports using SuperTRUMP and how to create custom Word templates incorporating results that can be printed directly from SuperTRUMP.

EBOs & Termination Values

A look at how SuperTRUMP calculates Termination Values and Schedules, and how to price an Early Buy Out structure.

Expense Modeling

Learn techniques to capture fixed and variable expenses in pricing models; discuss issues and possible solutions beyond just targeting a yield sufficient to recapture expenses.

Lease Classification

Learn the ins and outs of classifying leases for taxes (true lease vs. conditional sale) and for accounting (capital vs. operating).

Lease Purchase

Discuss the methods built into SuperTRUMP to handle interest and rent accrued prior to the purchase date; manually work through a lease purchase example.

Like Kind Exchange(LKE)

Use SuperTRUMP's LKE features to model the benefit of a given LKE tax deferral on a qualifying pricing.

Modeling for Business Forecasting

Use SuperTRUMP as a powerful forecasting tool to model "what if" scenarios for business projections; create portfolios of leases to model expected sales over given periods to analyze yields and expenses.

Optimization

The basics of setting up saw-toothed rent and debt structures to drive down the present value of rent or to enhance a yield.

Portfolio

Combine individual transactions in portfolios, modify selected transactions in various ways, perform sensitivities, analyze for sale or purchase and print reports on the portfolio.

Shadow Pricing

Do you have existing runs you need to enter into SuperTRUMP? We show you how to shadow price a pre-paid/deferred structure with an EBO and possibly even a 467 loan.

SuperTRUMP Integration

For sales and pricing managers interested in learning how integration can benefit them. The future of SuperTRUMP integration with other software and customer web sites will be discussed. A demonstration of the XML interface and SuperTRUMP server is provided. Members of the Ivory team will be available afterward to discuss user-specific integration projects.

Syndication

Accurate pricing for the syndication of loans used to require hours at a spreadsheet. Learn to use SuperTRUMP to create and modify even the most complex syndication scenario in a few minutes.
